HAMILTON BROWN/BUSHNELL SHORE WATER DISTRICT IMPROVEMENT PROJECT ESTABLISHING BID OPENING DATE

Supervisor Becker advised the Town Board is planning to advertise a bid opening for the Hamilton Brown/Bushnell Shore Water District Improvement Project. Currently, per Supervisor Becker there is grant money available for the proposed project and the Town Board would like to take advantage of this available funding and begin the project for the residents in this area. The suggested bidding schedule is to advertise the bid no later than August 30, 2021 with a bid opening date of September 29, 2021 with the Town Board taking action at the regular Town Board meeting on October 6, 2021. Engineer John Dunkle of Dunn & Sgromo Engineers, PLLC will be available for questions from interested contractors/bidders no later than September 28, 2021 by 5:00 p.m. The Town Board members discussed the proposed bid opening schedule. Upon the motion made by Councilor Ranger, seconded by Councilor Kopp, the Town Board will set a bid opening date of September 29, 2021 at 10:00 a.m. for the Hamilton Brown/Bushnell Shore Water District Improvement Project. PURCHASE OF GRADALL – HIGHWAY DEPARTMENT

Supervisor Becker spoke with the Board in regard to the plan to purchase a new Gradall for the Highway Department. He inquired if the Town Board wanted to begin the process for purchase of this equipment for a cost of \$446,580.54, which includes the specification change for a dual axle. The plan would be to purchase the unit without financing as follows: \$50,000.00 anticipated trade-in value of old Gradall, \$50,000.00 from Oneida Indian Nation Fund, and budgeting for 2022 and 2023 Town budgets with a final payoff in the 2024 Town Budget. Payment would be made December 2021. This payment plan would save the cost of finance. Councilors Martin and Brzuszkiewicz have both reviewed the financial information per Supervisor Becker. Councilor Ranger would like to wait to begin approval process until the next regular meeting when all Councilors would be available. This matter will be discussed at the September 1, 2021 meeting. No action was taken today.
