HIGHWAY FUEL TANK BID

Supervisor Becker reported that two bids were received at the bid opening on July 1, 2021 for the Highway Fuel Tank replacement.

2.	Lift Safe Fuel Safe, Inc. from Syracuse, NY	\$96,500

Highway Superintendent Busa has reviewed the bid documents and recommends awarding the bid to Walter's West End Supply, Inc. This purchase wouldn't be paid for until after January 2022. Upon the motion made by Councilor Martin, seconded by Councilor Kopp, the Town Board awarded the bid to Walter's West End Supply Inc. in the amount of \$92,600 as the low bidder. Highway Superintendent Busa commented that once the Company is notified of the bid award, they will prepare tank specification blueprints for review. RESOLUTION TO ELIMINATE LOCAL FILING FEE FOR MARRIAGE LICENSE APPLICATIONS BY ACTIVE-DUTY MILITARY

A request was received from the Clerk's Office in regard to eliminating the local filing fee for marriage license applications filed by active-duty military applicants. In 2019, Governor Cuomo signed legislation waiving marriage license fees (at the State level) for active-duty members of the Armed Forces. The legislation left it the local municipality whether or not to waive the local application filing fee. The local fee is \$17.50. Deputy Town Clerk Doss explained the enactment that took place in 2019. What brought it to light was a recent application by an active-duty military individual who mentioned the legislation. The Board discussed the request to waive the local marriage application fee for active-military. Upon the motion made by Councilor Martin, seconded by Councilor Ranger, the Board approved the request to waive the local application fee charged for active-military marriage license applicants effective immediately. ANNOUNCEMENTS

Supervisor Becker shared some announcements with the Board.

He has received correspondence from Supervisor DiVeronica from the Town of Lenox in regard to placement of three (3) historical signs down by the muck lands as follows:

- 1. Pine Ridge Road and Gee Road
- 2. Ditch Bank Road and Gee Road
- 3. Tag Road and Gee Road

Supervisor DiVeronica has asked if the Town of Sullivan budgeted for these signs. Supervisor Becker reported that the Town had budget money for signage about four years ago. He will get back to the Board on signage cost.

Supervisor Becker advised he had received information from County Administrator Mark Scimone about the Property Tax Cap and anticipated inflation information for 2022. Supervisor Becker highlighted some of the inflation data with the Town Board.

Supervisor Becker reported he had received information in regard to the Chittenango Service Area on the Thruway. The Chittenango Service Area Restaurant will close as of midnight July 28th. The gas station and truckers' parking will remain open. The contractor will start setting up their fence barriers the morning of the 29th. The contractor will be installing and providing temporary utilities to the gas station and wastewater treatment plant. Demolition of the main building is scheduled to start the week of August 16th.

Supervisor Becker advised that ribbon cutting was held at the new Madison County Highway Facility in the Eaton, New York today. The plan is for the move in to take place next week.

PROPOSED LOCAL LAW B-2021 - OVERRIDING TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW 3-C IN TOWN OF SULLIVAN

Councilor Martin introduced proposed Local Law No. B-2021, relating to the ability of the Town of Sullivan to override the limit on the amount of real property taxes that may be levied by the Town of Sullivan pursuant to General Municipal Law §3-c, and to allow the Town of Sullivan to adopt a Town budget for the fiscal year 2022 in excess of the "tax levy limit," if necessary, and made the following motion, which was seconded by Councilor Kopp:

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Sullivan, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption to said Local Law is an unlisted action for purposes of environmental review under SEQR; and

WHEREAS, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the enactment of proposed Local Law No. B-2021 is an unlisted action, there are no other involved agencies and this Board shall act as lead agency in this matter for purposes of SEQR review; and it is further

RESOLVED AND DETERMINED, the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQR; and it is further

RESOLVED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. B-2021 at the Town Hall located at 7507 Lakeport Road, Chittenango, New York on August 4, 2021 at 6:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and be it further

SEWER INSTALLATION APPLICATION FEE RESOLUTION

Highway Superintendent Andy Busa inquired if the Town Board would be taking any action on the recommended sewer installation application fees. The Board discussed the recommended changes to the fee schedule, which would reflect an increase of the current application fee to \$500 per connection. Thereafter, the following action took place:

The following resolution was offered by Councilor Martin, who moved its adoption, seconded by Councilor Ranger, to wit:

WHEREAS, the Town of Sullivan keeps and maintains various sewer improvements throughout the Town and its various approved Sewer Districts; and

WHEREAS, the Town Board deems it important to have uniform rules associated with individual sewer connections for all of those individuals desiring to connect to Town Sewer District improvements; and

WHEREAS, the Town Board further has determined that reasonable and appropriate sewer connection fees should be adopted and reviewed from time-to-time; and

WHEREAS, recently the Town of Sullivan Highway Superintendent has proposed the use of a uniform "Town of Sullivan Sewer Facility Connection Information Sheet", a "Town of Sullivan - Intake Procedures Sewer Facility Connection Requests" form, a "Town of Sullivan Hold Harmless Agreement (Sewer Connection Permit)" associated with said connection, and a "Town of Sullivan Highway Department/Sewer Superintendent Sewer Connection Permit" form; and

WHEREAS, the Town of Sullivan has reviewed individual connection fees for residential services in the Central New York area and has studied the reasonableness of said fees; and

WHEREAS, the Town of Sullivan Town Board has determined that a reasonable fee of \$500.00 per connection is fair and appropriate for new sewer connections and such

fee is designed to offset the actual cost incurred by the Town in said connection and inspection(s).

NOW, THEREFORE, BE IT RESOLVED that the Town of Sullivan Town Board hereby resolves that all future sewer connections to any Town of Sullivan public sewer system be charged at a rate of \$500.00 per connection; and be it further

RESOLVED that the following official forms shall be utilized by the Town of Sullivan in association with requests for connections into any public sewer system owned or controlled by the Town of Sullivan:

- Town of Sullivan Sewer Facility Connection Information Sheet;
- Town of Sullivan Intake Procedures Sewer Facility Connection Requests;
- Town of Sullivan Hold Harmless Agreement (Sewer Connection Permit); and
- Town of Sullivan Highway Department/Sewer Superintendent Sewer Connection Permit.

BARTON & LOGUIDICE – VARIOUS PROJECT UPDATES

Alex Hess and Taylor Bottar of Barton & Loguidice gave a brief overview and status update of three projects that Barton & Loguidice is currently working on.

-Bridgeport Sewer District – Extension 1

Alex Hess updated the Board on the proposed project which included information about the location and planned improvements, available funding programs through NYSEFC (WIIA) and USDA RD, explaining how they would be applied, the estimated annual cost per unit \$997 (based on 50% rule), the project schedule for SEQR and Bond resolutions in 2021, and the anticipated construction completion in 2025.

-Whitelaw Water District

Alex Hess updated the Board on the scope of the project which included the location and planned improvements, funding programs USDA RD and NYSEFC (WIIA) and explained how the funding would be applied, estimated annual cost per unit (\$861). The project schedule would begin in 2021 with finalization of the map, plan and report. Anticipated project completion would be 2025.

-Sleepy Hollow Water District Extension #1

Alex Hess reported that he has met with Highway Superintendent Busa, Frank Park from the Cemetery Association, and WD Malone representative to lay out the site for the pump station. The site will be mobilized within the next two weeks. The pre-fab pump station structure is almost complete and should be ready to ship within the next week. The water main and water services are anticipated for September with an anticipated completion of October. The issue at this time is obtaining the pipe for the project as there has been a great demand and low supply. Alex Hess will keep the Town informed of the status of

pipe delivery. Taylor Bottar advised that at this time the Town of Manlius and Town of Sullivan water district projects will not be moving forward. The Board thanked Alex and Taylor for the updates.

TEMPORARY EASEMENT - MR. & MRS. KIEFFER, 103 SLEEPY HOLLOW ROAD

Supervisor Becker spoke in regard to the temporary easement for access to the Kieffer property. Upon the motion made by Councilor Martin, seconded by Councilor Kopp, the Board authorize Supervisor Becker to sign the temporary easement for Mr. & Mrs. Kieffer of 103 Sleepy Hollow Road. With no further discussion, the following vote was recorded:
