# TOWN OF SULLIVAN AND SPECTRUM CABLE FRANCHISE AGREEMENT: SETTING A PUBLIC HEARING

The following resolution was offered by Councilor Martin, who moved its adoption, and seconded by Councilor Kopp, to wit:

**WHEREAS**, an application has been duly made to the Town Board of the Town of Sullivan, County of Madison, New York, by Spectrum Northeast LLC, 1/k/a Charter Communications, a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 6005 Fair Lakes Road, East Syracuse, NY 13057, for the approval of a renewal agreement for Spectrum Northeast LLC's cable television franchise for ten (10) years commencing with the date of approval by the Public Service; and

**WHEREAS**, the Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings; and

**WHEREAS**, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a resolution in the Town of Sullivan, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said resolution; and

**WHEREAS**, the adoption of said resolution is a Type II action for purposes of environmental review under SEQRA thus concluding the environmental review process.

NOW THEREFORE, BE IT RESOLVED AND DETERMINED that the Town Board will hold a public hearing on February 3, 2021 at 6:15 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested will be heard, using the online streaming service known as YouTube (<a href="https://www.youtube.com/channel/UCr9O9yfy128B6AwR4nu6">https://www.youtube.com/channel/UCr9O9yfy128B6AwR4nu6</a> Q) (due to the current Covid-19 pandemic, meetings shall be held in this manner until further notice when meetings shall resume being held at the Sullivan Town Hall, 7507 Lakeport Road, Chittenango, New York), for consideration of the granting of the Cable Franchise Agreement of Spectrum Northeast LLC and the Town of Sullivan for ten (10) years commencing with the date of approval by the Public Service Commission and expiring ten (10) years hence. Should the public wish to participate in the public hearing, the Town has posted an informational sheet on their website (<a href="www.townofsullivanny.gov">www.townofsullivanny.gov</a>) and their Facebook page outlining the steps that will need to be completed so that questions can be asked in real time. A copy of the agreement is available for public inspection during normal business hours at the Town Clerk's office, 7507 Lakeport Road, Chittenango, New York.

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, a proposed Local Law No. D-2020, "A Local Law to Amend the Town of Sullivan Zoning Law, by Amending Article IX ("Solar Energy Systems") at §275-50 ("Solar Farms"), Subparagraph "B" ("Districts Where Prohibited") and Adding New Subparagraph "R" ("Road Remediation")", which would prohibit Solar Farms on all lands north of New York State Route 31 in the Town of Sullivan between the boundaries of the Town of Cicero and the Town of Lenox, and require developers to post a public improvement bond for damage to local roads prior to the issuance of any building permits was presented and introduced at a regular meeting of the Town Board of the Town of Sullivan held on November 18, 2020; and

WHEREAS, a public hearing was held on such proposed local law on December 16, 2020, by the Town Board of the Town of Sullivan and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Sullivan in its final form in the manner required by Section 20 of the Municipal Home Rule Law of the State of New York; and

**WHEREAS**, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law of New York (SEQRA), requires that as early as possible in the consideration of a proposed action, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

**WHEREAS**, on November 18, 2020 the Town Board declared itself lead agency and determined that the enactment of proposed Local Law No. D-2020 is an unlisted action and will have no significant effect on the environment, issuing a negative declaration, thus concluding environmental review under State Environmental Quality Review Act; and

**WHEREAS**, it is in the public interest to enact said Proposed Local Law No. D-2020.

**NOW, THEREFORE**, it is

**RESOLVED** that the Town Board of the Town of Sullivan, Madison County, New York, does hereby enact Proposed Local Law No. D-2020 as Local Law No. 1-2021 as follows:

# "TOWN OF SULLIVAN LOCAL LAW NO. 1 FOR THE YEAR 2021

A LOCAL LAW TO AMEND THE TOWN OF SULLIVAN ZONING LAW, BY AMENDING ARTICLE IX ("SOLAR ENERGY SYSTEMS") AT §275-50 ("SOLAR FARMS"), SUBPARAGRAPH "B" ("DISTRICTS WHERE PROHIBITED") AND ADDING NEW SUBPARAGRAPH "R" ("ROAD REMEDIATION")

Be it enacted by the Town Board of the Town of Sullivan as follows:

#### **SECTION 1. AUTHORITY.**

This Local Law is enacted pursuant to the New York State Constitution and New York Municipal Home Rule Law §10.

#### **SECTION 2.** PURPOSE AND INTENT.

The Town of Sullivan Town Board has observed the proliferation of large scale solar facilities throughout Central New York in recent years. This proliferation is anticipated to continue

and increase as New York State continues to incentivize such projects. The Town therefore desires to address the potential negative impacts of such large scale projects by designating areas where large scale solar would tend to have negative impacts on property owners and small scale neighborhoods including areas located north of New York State Route 31. Further, the Town desires to address the potential negative impacts to local roads caused during the construction or completion of the installation of solar facilities.

# SECTION 3. AMEND ARTICLE IX ("SOLAR ENERGY SYSTEMS"), §275-50 ("SOLAR FARMS"), SUBPARAGRAPH "B" ("DISTRICTS WHERE PROHIBITED") OF THE TOWN OF SULLIVAN ZONING LAW.

Article IX ("Solar Energy Systems") at §275-50 ("Solar farms"), Subparagraph "B" ("Districts where prohibited") of the Town of Sullivan Zoning Law is hereby amended and replaced in its entirety with the following:

"B. Districts where prohibited. Solar farms shall be prohibited in the Low Density Residential (LR-40) District, the Medium Density Residential (MR-12) District and other zoning districts not specifically authorized for such use. Notwithstanding anything in this Chapter to the contrary, Solar farms are also hereby expressly prohibited on all lands north of New York State Route 31 in the Town of Sullivan between the boundaries of the Town of Cicero and the Town of Lenox."

# SECTION 4. AMEND ARTICLE IX ("SOLAR ENERGY SYSTEMS"), §275-50 ("SOLAR FARMS"), ADDING NEW SUBPARAGRAPH "R" ("ROAD REMEDIATION") OF THE TOWN OF SULLIVAN ZONING LAW.

Article IX ("Solar Energy Systems") at §275-50 ("Solar farms"), of the Town of Sullivan Zoning Law is hereby amended to add a new Subparagraph "R" ("Road remediation") as follows:

"R. Road Remediation. The applicant shall be responsible for remediation of roads damaged upon or if necessary, during the construction of and/or completion of the installation of any solar farms approved pursuant to this Section. The Code Enforcement Officer is hereby authorized and directed to ensure a public improvement bond be posted prior to the issuance of any building permit in an amount sufficient to compensate the Town for any damage to local roads that is not corrected by the applicant. The Code Enforcement Officer is authorized to consult with any necessary professional to determine or confirm the bond amount all at the sole cost and expense of the applicant."

#### **SECTION 5. SEVERABILITY.**

If any clause, sentence, paragraph, subdivision or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of

competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

# **SECTION 6. EFFECTIVE DATE.**

This Local Law shall be effective upon filing with the office of the Secretary of State."
