

**NOTICE OF PUBLIC HEARING  
TOWN OF SULLIVAN**

**NOTICE IS HEREBY GIVEN** that there has been presented to the Town Board of the Town of Sullivan, New York, at a regular meeting thereof held on June 17, 2002 and October 7, 2020, proposed Local Law No. C of 2020, “A Local Law Creating The Wild Drive Thru Safari Planned Development District.” Said Local Law, if enacted, would approve the application and Preliminary Development Plan submitted by Jeffrey S. Taylor II, as owner of the proposed “The Wild Drive Thru Safari”, with a street address of 7591 Lakeport Road, Chittenango, New York, and occupying lands designated and generally known as Town of Sullivan Tax Map No. 33.1-1-5.2 and containing approximately 40.03± acres, and establish “The Wild Drive Through Safari Planned Development District” on said lands, subject to the provisions of Section 275-12 of the Code of the Town of Sullivan. Said Local Law has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law. The full text of said Local Law is on file at the Town Clerk’s Office at the Town Hall located at 7507 Lakeport Road, Chittenango, New York for inspection by all interested persons, and available online at [www.townofsullivanny.gov](http://www.townofsullivanny.gov).

**NOTICE IS FURTHER GIVEN** that on June 17, 2020, the Town Board declared itself to be Lead Agency and determined that this proposed Local Law is a Type I Action for purposes of the State Environmental Quality Review Act (SEQRA). No final determination of environmental significance has been made.

**NOTICE IS FURTHER GIVEN** that the Town Board will hold a public hearing on the proposed Local Law using the online streaming service known as YouTube ([https://www.youtube.com/channel/UCr9O9yfy128B6AwR4nu6\\_Q](https://www.youtube.com/channel/UCr9O9yfy128B6AwR4nu6_Q)) on November 4, 2020 at 6:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested will be heard (due to the current Covid-19 pandemic, meetings shall be held in this manner until further notice when meetings shall resume being held at the Sullivan Town Hall, 7507 Lakeport Road, Chittenango, New York). Should the public wish to participate in the public hearing, the Town has posted an informational sheet on their website ([www.townofsullivanny.gov](http://www.townofsullivanny.gov)) and their Facebook page outlining the steps that will need to be completed so that questions can be asked in real time.
