RESOLUTION FOR NYS LOCAL GOVERNMENT RECORDS

WHEREAS, the Town of Sullivan is a local government that is required by New York State to retain records pursuant to minimum standards set forth according to Article 57-A (Local Government Records Law) of the Arts and Cultural Affairs Law; and **WHEREAS**, the New York State Archives, a part of the Office of Cultural Education of the New York State Education Department, has required all local governments to adopt the newly published *Retention and Disposition Schedule for New York Local Government Records* (LGS-1); and

WHEREAS, the Town of Sullivan seeks to adopt the LGS-1 in order to adequately preserve and retain records in accordance with state law; and

NOW, THEREFORE BE IT RESOLVED that in accordance with Article 57-A:

- 1. only those records will be disposed of that are described in *Retention and Disposition Schedule for New York Local Government Records* (LGS-1), after they have met the minimum retention periods described therein; and
- 2. only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.

DISCUSSION ON SOLAR MORATORIUM AND MODIFICATIONS TO THE EXISTING SOLAR LAW

Supervisor Becker stated that the current Solar Moratorium will expire on December 16, 2020. Discussion ensued regarding modifications to the Town's Solar Law to provide for no solar from the North of Route 31 and anything on the South side of Route 31 could be considered.

Thereafter, the following resolution was acted on, to wit:

TOWN OF SULLIVAN LOCAL LAW NO. D OF 2020

("A Local Law to Amend the Town of Sullivan Zoning Law, by Amending Article IX ("Solar Energy Systems") at §275-50 ("Solar Farms"), Subparagraph "B" ("Districts Where Prohibited") and Adding New Subparagraph "R" ("Road Remediation")")

Councilor Martin introduced proposed Local Law No. D-2020, "A Local Law to Amend the Town of Sullivan Zoning Law, by Amending Article IX ("Solar Energy Systems") at §275-50 ("Solar Farms"), Subparagraph "B" ("Districts Where Prohibited") and Adding New Subparagraph "R" ("Road Remediation")", which would prohibit Solar Farms on all lands north of New York State Route 31 in the Town of Sullivan between the boundaries of the Town of Cicero and the Town of Lenox, and require developers to post a public improvement bond for damage to local roads prior to the issuance of any building permits, and made the following motion which was seconded by Councilor Kopp:

WHEREAS, proposed Local Law No. D-2020 has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible after submission of a completed application, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Sullivan, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said proposed Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEQRA; and

WHEREAS, the Town Board has determined that a Short Environmental Assessment Form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE,

BE IT RESOLVED AND DETERMINED that the Town Board has determined that this action shall have no significant adverse impact on the environment; that, accordingly, an

environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQRA; and it is further

RESOLVED that this proposed Local Law shall be referred to the Madison County Planning Department pursuant to New York General Municipal Law §239; and it is further

RESOLVED that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. D-2020 at the Town Hall located at 7507 Lakeport Road, Chittenango, New York on December 16, 2020 at 5:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and be it further

RESOLVED that notice of said public hearing shall be provided at least five (5) days prior to the date of said public hearing in a newspaper of general circulation within the Town of Sullivan and to any affected municipalities described above.
