#### APPROVAL OF MINUTES OF MEETING

A motion was duly made by Councilor Brzuszkiewicz, seconded by Councilor Martin and unanimously passed by the Board to approve the minutes of the Town Board meeting of July 26, 2017 and August 2, 2017.

### POINT PLACE CASINO SEWER CONNECTION APPROVAL

A motion was duly made by Councilor Martin, seconded by Councilor Kopp and unanimously passed by the Board approving the Sewer Use and Connection Agreement to allow the Oneida Nation to connect to the public sewer system in Bridgeport.

# HIGHWAY SUPERINTENDENT SGROI PROPERTY 2241 ROUTE 31 AND MONROE AVE

Highway Superintendent Andy Busa approached the Board regarding an ongoing problem with the Sgroi property which is located at 2241 Route 31, Canastota New York and also a vacant property which is on Monroe Ave, Canastota New York. He stated that the Sgroi property is causing a major traffic issue and needs to be cleaned up. The owner is parking vehicles on a town road which is causing visibility and safety issues for vehicles traveling along this road. Superintendent Busa would like to place "No Parking" signs on the road right-of-way and wants to make sure that he is legally authorized to do so. The State Police have been called many times regarding the visibility issue, however, until the signs are in place they cannot act on correcting this problem. Fire Inspector William Pindle stated that these vehicles are an obstruction to fire service in that area also.

#### OTHER MATTERS BROUGHT BEFORE THE BOARD

- 1. Councilor Brzuszkiewicz asked Supervisor Becker for a progress report on having the structure taken down on property owned by Tim Honors on Route 31 in Bridgeport. Supervisor Becker stated that this has been an ongoing problem with Mr. Honors and he, as well as the Board, would like to see it resolved with the property cleaned up. Supervisor Becker is going to contact the City of Rome and possibly contract with them for asbestos cleanup. He will get back to the Board with the possibility of taking this action.
- Councilor Kopp informed the Board that he had attended a press conference held by the Chittenango Fire Department last week regarding a proposed law that will give Cancer Insurance to volunteer fire personnel who get cancer while serving as a volunteer. He stated that it was very informative and he will keep the Board informed of the outcome.
- 3. Art Lelio (resident of the Town of Sullivan) asked Supervisor Becker for an update on the issue of people occupying travel trailers that are parked on private property. Supervisor Becker stated that the Board is continuing to investigate the need for a new law because the problem is only being caused by a few people. Supervisor Becker further stated that he will inform the public prior to any decision being made on this issue.
