A regular meeting of the Town Board of the Town of Sullivan was convened at the Town Office Building by Supervisor John M. Becker at 9:00 A.M.

Those in attendance for the meeting were: Supervisor John M. Becker; Councilors: Thomas Kopp, Jeff Martin; and Kerry Ranger; Highway Superintendent Andy Busa; Attorney for the Town John Langey; Comptroller Beth Ellis; and Town Clerk Charlotte A. Ferstler.

Councilor John Brzuszkiewicz was excused.

Also in attendance were: Robert and Marilyn Dempster and Art Lelio.

Pledge to the flag was led by Supervisor Becker.

# APPROVAL OF MINUTES OF MEETING

A motion was duly made by Councilor Martin, seconded by Councilor Kopp and unanimously passed by the Board to approve the minutes of the Town Board meeting of December 6, 2017.

# **BUDGET MODIFICATIONS FOR DECEMBER 20, 2017**

# 1) Transferring \$46,233.23 from A230 to A5132.486 Highway Garage. This is to pay for Heating Improvements completed at the Highway Garage.

# OTHER MATTERS BROUGHT BEFORE THE BOARD

1. Robert and Marilyn Dempster, 9002 North Road, Bridgeport New York, addressed the Board for information regarding the Bridgeport Sidewalk Project. Mr. and Mrs. Dempster's property is on the corner of North Road and Bielec Road in Bridgeport. Mr. Dempster stated that the engineers are in the process of digging test holes for the sidewalks and he is concerned that there are existing utilities along the same path where they are digging.

Supervisor Becker asked Highway Superintendent Busa to contact the Madison County Highway Superintendent, Joseph Wisinski, and advise him of the unmarked storm sewer. Supervisor Becker stated that the original project was to bring the sidewalks back on Route 31 from the Methodist Church up to the Fire Station. He stated that the Project was to be put on hold.

Supervisor Becker stated that the Board will put together a committee of volunteers and Councilors to look into the sidewalk project. He further stated that they have approximately \$800,000.00 to work with from the Streetscape Grant they had received. Mrs. Dempster volunteered to be on the committee when it is formed. Supervisor Becker thinks that a Committee will be able to move this project along with new ideas and communication.

Mr. Dempster is also very concerned with drainage problems along North Road, between the Methodist Church and Bielec Drive. He stated that the water comes out of the Church parking lot and collects at the corner of Bielec Drive and he does not want the new sidewalk project to increase this drainage problem.

Mrs. Dempster spoke to the Board regarding issues with the new Oneida Nation Casino and how it will impact the Bridgeport area. She specified the all-night lighting, traffic increase which will necessitate a need for widening Route 31 and the drainage problems it may cause. Supervisor Becker assured the Dempsters that the Oneida Nation has been very willing to work with the Town of Sullivan up to this point and he is willing to bring any issues to the Nation as they occur.

Mrs. Dempster asked the Board if the Grant money could be used for correcting odors coming from the sewer pump stations. Supervisor Becker stated that the money can only be spent on what the Grant was awarded for. He and Highway Superintendent Busa discussed making changes to the venting system for the pumping station, which they think may correct some of the problem. They discussed changing the location of the exhaust pipe, raising the vent pipe and installing a charcoal filter, all as possible improvements. # DELPHI FALLS PURCHASE BY MADISON COUNTY

Supervisor Becker reported to the Board that Madison County has purchased certain Delphi Falls property as a park. As previously reported, a benefactor has given Madison County \$750,000.00 and Madison County will contribute \$150.000.00 for the purchase. He stated that all but three Towns voted in favor of the Purchase.

Supervisor Becker also reported that Madison County has transferred their Sewer District to the Town of Cazenovia.

Councilor Kopp reported that the Village has contracted with the Oneida Nation to allow discharge into the Village Treatment Plant from the new convenience store on NYS Route 31.

# RETURN TO SIDEWALK DISCUSSION

Following further discussion, it was the decision of the Board that Supervisor Becker will contact Barton and Logudice, Engineers for the Town of Sullivan, and instruct them to stop digging test holes until the Town has a final plan and drawings. Supervisor Becker said that they should find out if Route 31 is going to be widened before they get much further into the sidewalk project.

Marilyn Dempster questioned what will happen with the Grant money if the sidewalk project falls thru. Supervisor Becker stated that the money would have to be returned as it can only be used for the sidewalks or green space for the sidewalks.

A motion was duly made by Councilor Martin, seconded by Councilor Kopp and unanimously passed by the Board to go into executive session for advice of Counsel at 9:43 A.M.
