("A Local Law Repealing Article II ('Building and Fire Code') of Chapter 123 ('Construction Codes, Uniform') of the Town of Sullivan Town Code in its Entirety")

The following resolution was offered by Councilor Martin, who moved its adoption, seconded by Councilor Brzuszkiewicz, to wit:

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, a proposed local law titled Local Law No. B-2018, "A Local Law Repealing Article II ('Building and Fire Code') of Chapter 123 ('Construction Codes, Uniform') of the Town of Sullivan Town Code in its Entirety", was presented and introduced at a regular meeting of the Town Board of the Town of Sullivan held on March 21, 2018; and

WHEREAS, a public hearing was held on such proposed local law on this 4<sup>th</sup> day of April, 2018, by the Town Board of the Town of Sullivan and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Sullivan in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

**WHEREAS**, the enactment of Proposed Local Law No. B-2018 has previously been determined to be an Unlisted Action and will have no significant effect on the environment thus concluding the SEQR review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. B-2018.

# NOW, THEREFORE, it is

**RESOLVED**, that the Town Board of the Town of Sullivan, Madison County, New York, does hereby enact proposed Local Law No. B-2018 as Local Law No. 1-2018 as follows:

## **TOWN OF SULLIVAN LOCAL LAW NO. 1 OF 2018**

## A LOCAL LAW REPEALING ARTICLE II ("BUILDING AND FIRE CODE") OF CHAPTER 123 ("CONSTRUCTION CODES, UNIFORM") OF THE TOWN OF SULLIVAN TOWN CODE IN ITS ENTIRETY

Be it enacted by the Town Board of the Town of Sullivan as follows:

# SECTION 1. AUTHORITY.

This Local Law is enacted pursuant to the New York State Constitution and New York Municipal Home Rule Law §10.

## **SECTION 2.**

Chapter 123, Article II, titled "Building and Fire Code", of the Code of the Town of Sullivan, which Article promotes and maintains the safety, health and general welfare of Town residents by establish certain building and fire code regulations for residences within the Town of Sullivan, is hereby repealed in its entirety and the use of the "Town of Sullivan Building and Fire Code Law" is discontinued.

## SECTION 3. SEVERABILITY

If any clause, sentence, paragraph, section, article or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operations to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

## SECTION 4. EFFECTIVE DATE

This Local Law shall take effect upon filing with the Secretary of State."

WHEREAS, a public hearing was held on such proposed local law on this 4<sup>th</sup> day of April, 2018, by the Town Board of the Town of Sullivan and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Sullivan in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

**WHEREAS**, the enactment of Proposed Local Law No. B-2018 has previously been determined to be a Type I Action and will have no significant effect on the environment thus concluding the SEQR review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. C-2018.

## NOW, THEREFORE, it is

**RESOLVED**, that the Town Board of the Town of Sullivan, Madison County, New York, does hereby enact proposed Local Law No. C-2018 as Local Law No. 2-2018 as follows:

## **TOWN OF SULLIVAN LOCAL LAW NO. 2 OF 2018**

## A LOCAL LAW CREATING A NEW SECTION FOR CHAPTER 275 (ZONING) OF THE CODE OF THE TOWN OF SULLIVAN TO PROVIDE FOR AGRICULTURAL ASSOCIATED LOW-IMPACT STORAGE/WAREHOUSING IN THE TOWN OF SULLIVAN

Be it enacted by the Town Board of the Town of Sullivan as follows:

# SECTION 1. AUTHORITY.

This local law is enacted pursuant to the New York State Constitution and New York Municipal Home Rule Law §10.

# SECTION 2. PURPOSE

The Town of Sullivan recognizes that certain established agricultural operations within the Town's Agricultural Zoning District with existing large agricultural buildings may provide the property owner, in certain instances, the ability to provide for low-impact storage/warehousing services with no detriment to surrounding neighbors. It is therefore deemed desirable to provide for agricultural associated low-impact storage/warehousing in such areas upon issuance of a Site Plan Approval by the Town's Planning Board.

## SECTION 3.

**Section 275-2** ("Definitions") of Chapter 275 of the Code of the Town of Sullivan is hereby amended by adding a new definition of "Agricultural Associated Low-Impact Storage/Warehousing" alphabetically therein to read in its entirety as follows:

"Agricultural Associated Low-Impact Storage/Warehousing - An existing agricultural parcel providing large onsite agricultural storage/warehousing services on premises, including but not limited to existing enclosed pole barns, enclosed masonry storage buildings and enclosed farm structures with a minimum individual square footage of 8,000 sq. ft., which enclosed structures were constructed prior to 1. 1985. 'Agricultural Associated Low-Impact Januarv Storage/Warehousing' does not include retail business or other uses separately listed in this Chapter. Agricultural Associated Low-Impact Storage/Warehousing is allowed upon the granting of Site Plan Approval, only in the Agricultural District and as otherwise authorized by §275- ."

## SECTION 4.

**275 Attachment 2** ("Zoning Use Table") of the Code of the Town of Sullivan is hereby amended by adding a new permitted use (P) in the "A" (Agricultural) District as follows:

"Agricultural Associated Low-Impact Storage/Warehousing"

#### SECTION 5.

**Article V** ("Special Procedures and Standards") of Chapter 275 of the Code of the Town of Sullivan is hereby amended by adding a new subsection 275-\_\_\_\_ to read in its entirety as follows:

"§275-\_\_\_\_. Agricultural Associated Low-Impact Storage/Warehousing.

Low-impact storage/warehousing services shall be allowable only within the Agricultural District subject to the granting of Site Plan Approval by the Town Planning Board and specifically upon the following additional requirements:

- A. The property on which the agricultural associated low-impact storage/warehousing business is located shall be a minimum of 4 acres.
- B. The agricultural associated low-impact business must be contained within an existing structure having a minimum total building area of 8,000 sq. ft. Such existing building must have

been constructed prior to January 1, 1985. Expansion of the existing facilities shall be prohibited.

- C. A detailed Site Plan shall be prepared depicting all site amenities, including ingress, egress, lighting, proposed agricultural associated low-impact storage/warehousing area, any proposed attached signage and other features as deemed necessary by the Planning Board].
- D. All signage shall be attached to the building and must be approved by the Town of Sullivan Planning Board.
- E. The hours of operation associated with the agricultural associated low-impact storage/warehousing business shall be within the hours of 6:00 a.m. to 10:00 p.m. for deliveries and stocking of supplies.
- F. There shall be a written operation/business plan for the agricultural associated low-impact storage/warehousing business, which shall include a summary narrative specifically describing the proposed use, the nature of the storage, the existing buildings with drawings, access points and proposed hours of operation.
- G. There shall be no outdoor storage of any type associated with agricultural associated low-impact storage/warehousing business other than farm equipment.
- H. Agricultural associated low-impact storage/warehousing shall not include direct retail sales but shall be limited to storage and warehousing of goods or items onsite.
- I. Such agricultural associated low-impact storage/warehousing business must front upon, have direct access to or be within 100 feet of a County or New York State Highway with sufficient and safe sight distance for ingress and egress.
- J. All exterior lighting shall be maintained so as to not shine or spill onto neighboring properties or onto adjacent highways and shall be properly shielded.
- K. The parking of vehicles on-site in connection with the storage/warehousing use shall be limited to only those necessary to conduct the low-impact agricultural associated storage/warehousing business.
- L. No overnight parking visible from the road or adjoining properties shall be permitted.
- M. If deemed appropriate by the Planning Board, there shall be an annual inspection of the operations of the agricultural associated low-impact storage/warehousing business conducted by the Town Zoning Enforcement Officer.
- N. The Planning Board may establish appropriate screening to protect impacts to surrounding properties, including but not

limited to fencing, berms and tree and/or hedge plantings upon appropriate findings.

## SECTION 6. SEVERABILITY

If any clause, sentence, paragraph, section, article or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operations to the clause, sentence, paragraph, section, article, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

This Local Law shall take effect upon filing with the Secretary of State."

# HIGHWAY SUPERINTENDENT BUSA'S REQUEST FOR APPROVAL TO PURCHASE A NEW TRUCK (2018 FORD F-250) FOR THE SEWER/HIGHWAY DEPARTMENTS

Highway Superintendent Busa spoke with the Board regarding the possibility of purchasing a 2018 Ford F-250 Truck with plow for use by the Sewer Department and the Highway Department. He stated that the pickup they are using at this time is in very rough shape and should be replaced. He also stated that he has priced out taking an older vehicle and replacing the box and having it painted to match the other vehicles and feels that they would just be putting new money into an old vehicle. Superintendent Busa told the Board that he had received quotes from different Dealers and received a price from NYE Motors for \$46,595.00 which would be the State Bid price. (OGS Contract #PC67318; Award #22898).

A discussion followed with Councilor Ranger asking if it would be more economical to use an old highway truck for the Sewer Department and keep the new one for the Highway Department. Supervisor Becker stated that if Superintendent Busa gets a new vehicle he will take care of it and maintain it, so that it does not end up in the condition that the current sewer truck is. Councilor Ranger stated that he is not as concerned about the purchase of a new truck as he is about where the money is coming from to pay for the truck.

Further discussion followed regarding which account the \$46,595.00 should be taken from. Supervisor Becker stated that they can take the money from the Host Community Fund rather than the sewer fund which would cause a problem if there was an emergency. He stated that the Sewer Department still has to purchase grinder pumps, pipes and other parts for the upcoming year.

Councilor Martin asked Superintendent Busa if he needed the new truck and the answer was that the Sewer Department definitely needs a new or newer truck.

Supervisor Becker duly made a motion, seconded by Councilor Martin authorizing Highway Superintendent Busa to purchase a new 2018 Ford F-250 Truck from NYE Automotive Group LLC pursuant to State Bid (OGS Contract #PC67318; Award #22898) which will be used by the Highway Department and the Sewer Department at a price not to exceed \$46,595.00.

Supervisor Becker asked Highway Superintendent Busa to go to Marsh Mill Road and see if the Town can do anything to alleviate the flooding without causing problems for neighboring properties.
- 2.) Steve Burton also asked the Board if there was any chance for Marsh Mill to get natural gas. Councilor Brzuszkiewicz stated that he would look into the possibility and will contact National Grid.
- 3.) Brett Myles, 1243 Palmer Circle in Bridgeport, questioned Supervisor Becker on when they can expect the next phase of the Bridgeport Sewer Project to start. Supervisor Becker explained that until money, in the form of a grant, becomes available, there will not be any new progress with the sewers.
