A regular meeting of the Town Board of the Town of Sullivan was convened at the Town Office Building by Supervisor John M. Becker at 9:00 A.M.

APPROVAL OF MINUTES

A motion was duly made by Councilor Brzuszkiewicz, seconded by Councilor Ranger and unanimously passed by the Board to approve the minutes of the Town Board meeting on April 4, 2018.

BRIDGES REALITY CHECK GROUP

Bailey Foster, Chittenango Middle School Student, presented the Board with a video on Students voicing their concerns on tobacco use and how it's being marketed. The Students stated that the way tobacco is being marketed is sending mixed messages to teens and encouraging them to use tobacco products. Sue Casanova, Community Engagement Program Coordinator with BRIDGES, stated that the Family Tobacco Act has been passed. With the passing of this Law, Municipalities now have the opportunity to get involved and have a voice regarding the marketing of tobacco products in their jurisdiction. With the ease of access that teenagers have to tobacco products, it is more important than ever that our communities get involved and educate. Ms. Casanova stated that she will follow up with the Town Board in a couple of months.

REJECT ASPHALT BIDS

Highway Superintendent Busa requested that all bids received for the asphalt projects be rejected. TOWN OF SULLIVAN LOCAL LAW D OF 2018

("A Local Law to Amend the Town of Sullivan Zoning Law, as Adopted by Local Law No. 3 of 1979, By Amending the Definition of Kennel and Adding Certain Kennels, Animal Day Care and Dog Grooming as Specially Permitted Uses in the Agricultural (A), Business (B) and Industrial (I) Districts")

Councilor Ranger introduced proposed Local Law No. D-2018, "A Local Law to Amend the Town of Sullivan Zoning Law, as Adopted by Local Law No. 3 of 1979, By Amending the Definition of Kennel and Adding Certain Kennels, Animals Day Care and Dog Grooming as Specially Permitted Uses in the Agricultural (A), Business (B) and Industrial (I) Districts", which Local Law would create a new definition of the term "kennel" and allow certain kennels, animal day care and dog grooming as specially permitted uses in the Agricultural (A), Business (B) and Industrial (I) Districts within the Town of Sullivan, and made the following motion which was seconded by Councilor Kopp:

WHEREAS, proposed Local Law D-2018 has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible after submission of a completed application, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Sullivan, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said proposed Local Law, with the result that the Town Board shall act as lead agency in this matter.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Sullivan hereby determines that:

- 1. The action is a Type I action for purposes of SEQRA,
- 2. The Town Board of the Town of Sullivan shall act as lead agency;
- 3. The Village of Chittenango; Town of Cazenovia; Town of Cicero; Town of Fenner; Town of Lenox, Town of Lincoln; Town of Manlius; Madison County Planning Department; Syracuse-Onondaga County Planning Agency; New York State Department of Environmental Conservation, Region 7; and New York State Department of Agriculture and Markets are interested agencies in connection with the SEQRA review;

> 4. The action will require the submission of a Full Environmental Assessment Form to provide information with regard to the environmental issues pertinent therein; and it is further

RESOLVED that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. D-2018 at the Town Hall located at 7507 Lakeport Road, Chittenango, New York on May 2, 2018 at 7:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and be it further

RESOLVED that notice of said public hearing shall be provided at least ten (10) days prior to the date of said public hearing in a newspaper of general circulation within the Town of Sullivan and to any affected municipalities described above.

BUDGET MODIFICATION FOR APRIL 18, 2018

1) Transferring \$7,136.83 from Contingent A1990.4 to Engineers Fees A8030.460. This is the difference between the amount NYS EFC paid vs the amount owed on the Bridgeport Streetscapes project, which represents 10% local match and 5% retainage fee on the project.
